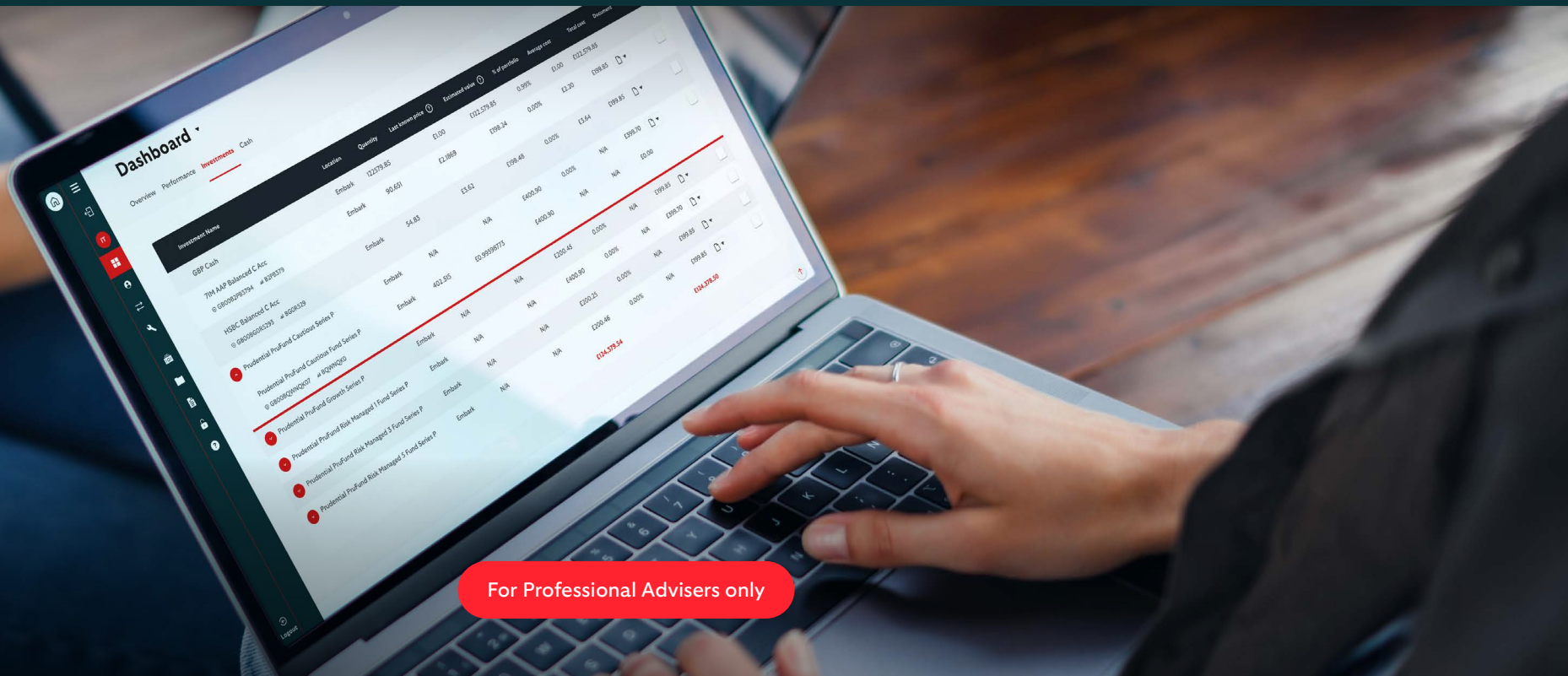

- You'll soon be able to access PruFund on our Platform. This has been fully integrated into our existing investment journeys, providing a seamless way to add PruFund to client portfolios.
- This gives you access to a market leading smoothed managed fund range, alongside the benefits of our modern digital platform capabilities and seamless adviser experience.

### Client Dashboard enhancements

We've also introduced the following improvements to the Client Dashboard to enhance your user experience.

- **Easier access to CGT tool:** You can now easily access our Capital Gains Tax (CGT) report and modelling directly from the new Tools section on the Dashboard.
- **Reduced pension income cancellation window:** We've shortened the cancellation window for pension withdrawals, helping to minimise issues.
- **Bank account payment type validation:** Improved validation means you'll now only be shown the appropriate bank account(s), based on the payment source selected.

You'll find more information on these enhancements in this guide. As the PruFund has been fully integrated into our existing investment journeys, the guide focuses on key points you need to know.

# Overview: Introducing PruFund to Scottish Widows Platform

The PruFund has been **built seamlessly into our existing investment journeys**, with clear messaging and prompts to guide you through the process.

Each PruFund consists of a Top-Level fund with two underlying sub investments, the Holding Fund and the Smoothed Fund.

All buy and sell transactions for PruFund are processed at the Top-level.

All new investments initially enter the Holding Fund and on the 25th of every month (or next working day), units from the Holding Fund are swept into the Smoothed Fund.

## Top-level Fund

- No ISIN and no price



## Holding Fund

- Own ISIN and daily priced
- All new investments go into this fund
- Units are swept out on the 25th of the month



## Smoothed Fund

- Own ISIN and daily priced
- Units are swept in on the 25th of the month

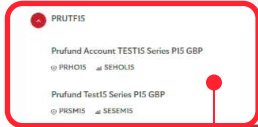

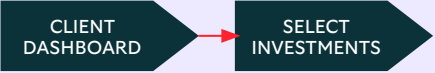

A message is displayed requesting you to acknowledge and undertake the required action(s) prior to completing a PruFund trade.



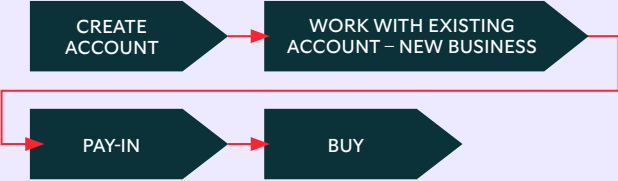
By selecting **Continue**, you will be confirming you are happy to proceed.

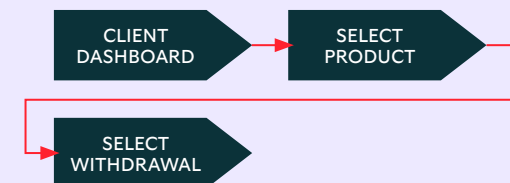

Only one sell reason can be captured per journey.

The 'I'm ready to sell' box will remain greyed out until a reason is selected.

Where there is a delayed sell, the pending transaction details tab will display the execution date. Until the date is confirmed TBD will be displayed.

Only one reason for a sell can be chosen per sell journey. All applicable fields are updated when the user selects the reason. There is more detail about this on the next page.

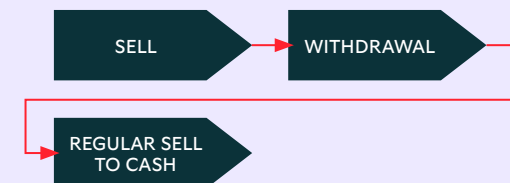
If there is an existing sale to cash, then Hold as cash will not be available for selection.

When the user requests to Hold as cash from PruFund, another cannot be requested for 90 days from the date that the first request is placed.

You can still make a sell for a withdrawal or for adviser charges while a delayed sell is in flight.

A message will inform you of the date you can make another sell to cash.

The 'I'm ready to sell' box will remain greyed out until a reason is selected.

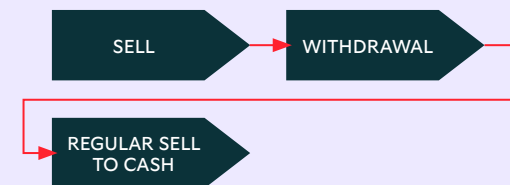
There is a choice of 'reason to sell' to select from. Reasons are product specific:

- Adviser ad hoc charges (Pension and ISA)
- PCLS (Pension only)
- Single flexi-access drawdown (Pension only)
- Uncrystallised pension payment (Pension only)
- Hold as cash (Pension and ISA)
- Withdrawal (ISA only)

A reason code is not requested for the following journeys as these are commonly used for the purpose of raising cash for fees and / or withdrawals:

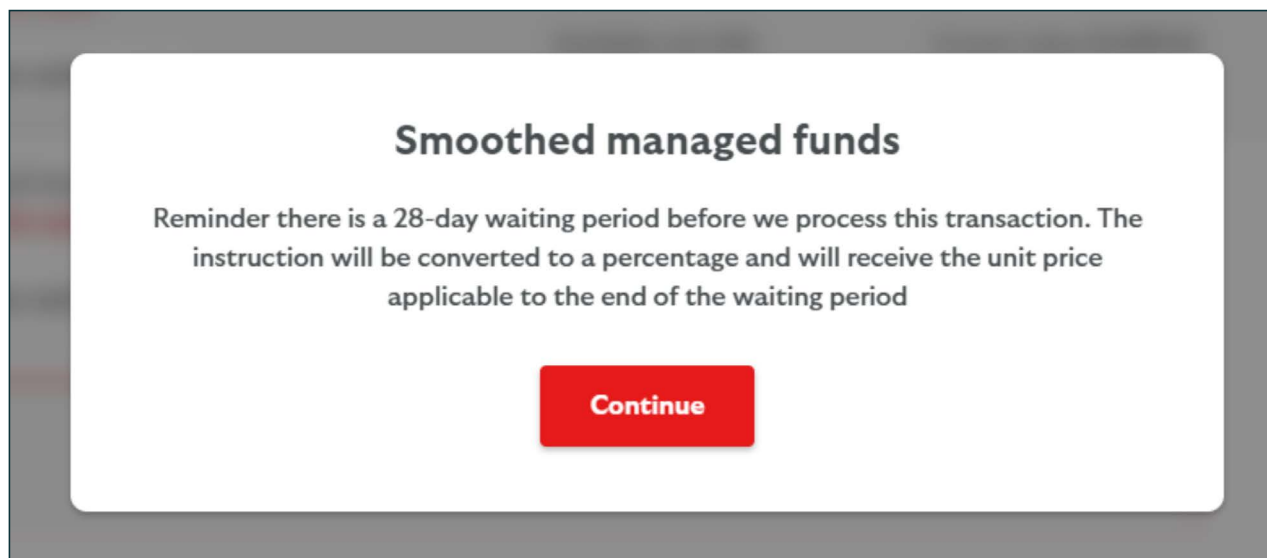

# Sell journey

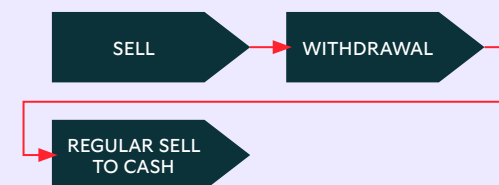
Final pop-up message to reminds users that there will be a 28-calendar day delay.



All delayed transactions are converted immediately as a percentage of the holdings.

If, between the switch being requested and executed, the value or quantity of the holding changes (for example, due to performance, additional investment or withdrawal), the original percentage is maintained and the value executed may differ from when the switch was requested.

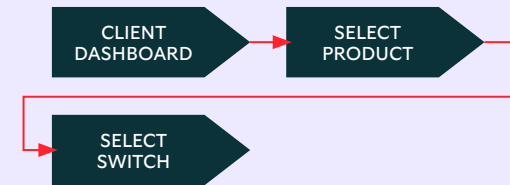
When PruFund is included in the sale leg of a switch, the transaction is delayed for 28 calendar days, and users will receive the delay warning message.

This is slightly different to the sell journey where you can continue, with limited options.

Due to different settlement dates, switches for PruFund and non-smoothed funds need to be carried out separately.

A reason code is not requested for the sell leg of a Switch journey as we know the purpose is to purchase a new investment.

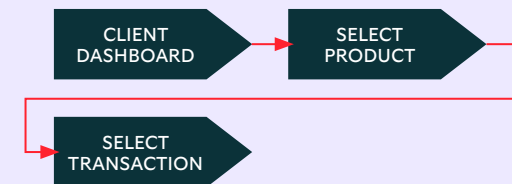

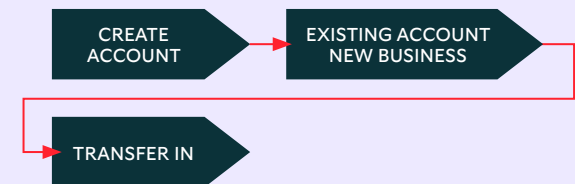

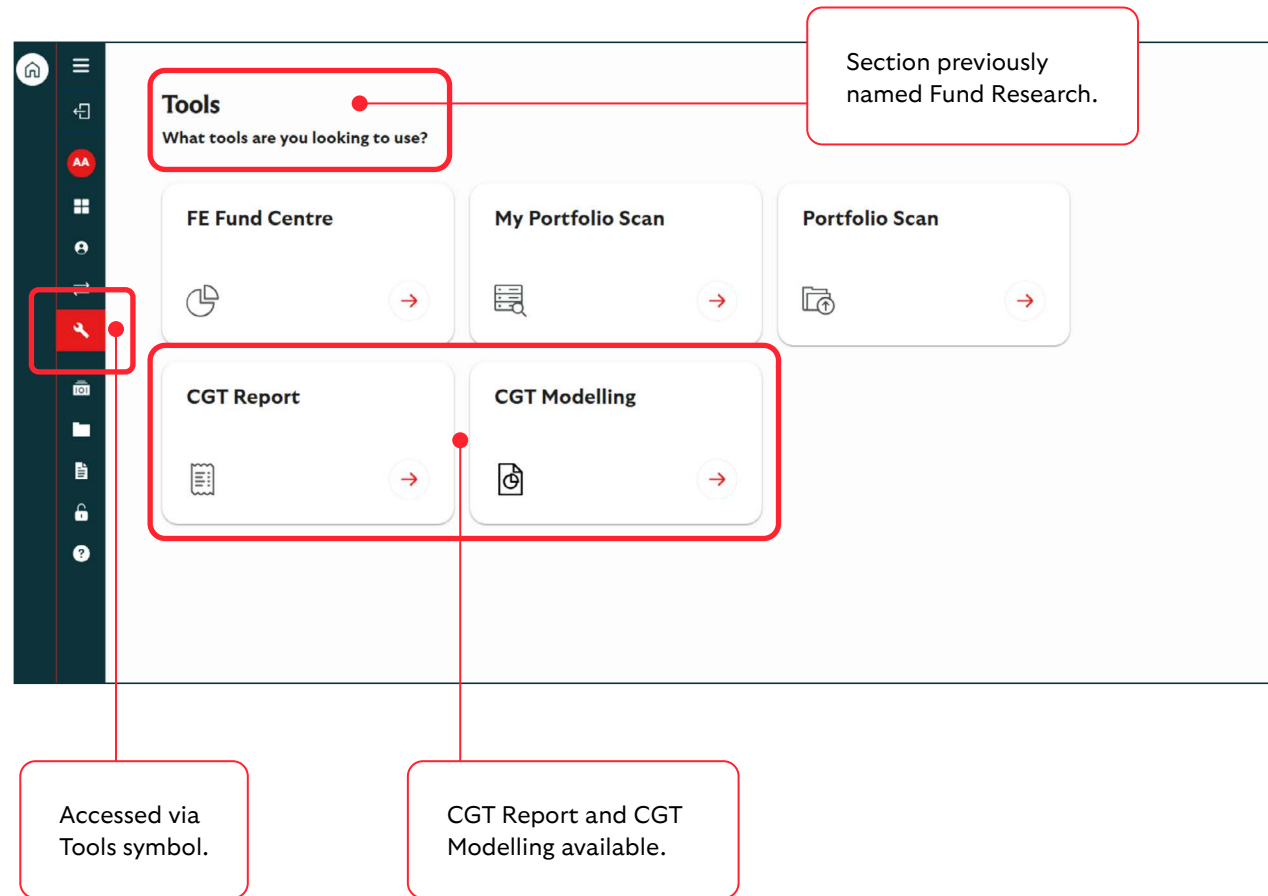
# Trading timelines for PruFund

Description	Timeline
Buy PruFund (into Holding fund sub investment)	Next available price point with a settlement date T+1 (Batch cut-off is 12:30pm)
Sweep process (into Smoothed fund sub-investment)	On the 25th of each month (or next working day for weekends and public holidays), all settled holdings in the Holding sub-investment will be swept into the Smoothed sub-investment
Sell PruFund: Hold as cash	Subject to a 28-calendar day delay and placed into the market the following day at the first available price point
Sell PruFund: any other reason (Withdrawal, Fees, UFPLS, Regular sell to cash)	Next available price point with a settlement date T+1 (batch cut-off 12:30 pm)
Switch from PruFund into another investment	Subject to a 28-calendar day delay and placed into the market the following day at the first available price point

# Access CGT tool from the Client Dashboard



Capital Gains Tax tool can now be easily accessed directly from the new tools section on the Client Dashboard.



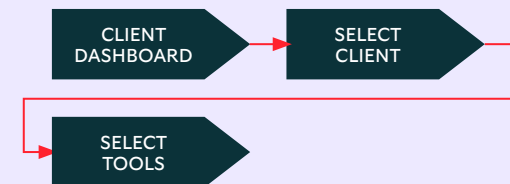
Our Capital Gains Tax (CGT) report and modelling, are now easily accessible via the new **Tools** section on the Client Dashboard.

With client context retained, this removes the need for time-consuming searches.

The **Tools** section was previously known as **Fund Research** and still contains links to FE Fund Centre and Portfolio Scan.

Note, the CGT tool will not be visible to end clients.

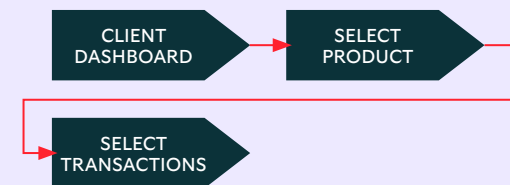

Cancel button will no longer be visible once a withdrawal has been authorised on the Platform.

The **Cancel** option will now be available during a shorter window. This will help prevent issues with PAYE reporting and reversing payments in the payroll system.

Now, you will not be able to cancel withdrawals once they have been authorised on the Platform. This applies to single withdrawals, including those derived from regular withdrawal instructions.

# Improved bank account payment type validation

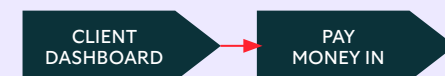
Enhanced validation means you will now only be shown the appropriate bank account(s) based on the payment source selected.



As part of the **Pay Money In** journey, when completing bank account details, you'll now be asked to select a **payment source** (Account holder, Employer, Third party).

Enhanced validation means that you will now only be shown the appropriate bank account(s) based on the payment source selected, ensuring payments are made from the correct source.
